



Lynnwood Idol Rules & Regulations

What is Lynnwood Idol All About?

The purpose of the Lynnwood Idol talent search is to develop and encourage amateur entertainers throughout South Snohomish County and for area residents to join in on the fun. Lynnwood Idol will provide entertainers with the opportunity to perform at the inaugural Billy McHale's Welcomes SoCo LoCo Festival and compete for cash prizes.

When Does the Contest Take Place?

Interested contestants must submit a completed application and entry form to the South Snohomish County Chamber of Commerce no later than 4 p.m. on Friday, July 21. A panel of judges will review the applications and schedule individuals to appear at the Chamber offices for a closed audition on Friday, August 4. From these auditions, the judges will select 10 to advance to the finals and perform at the Billy McHale's Welcomes SoCo LoCo Festival on Sunday, August 27. Winners will be awarded cash prizes in the amount of \$250 for first place, \$150 for second place and \$100 for third place.

What Are the Rules for the Competition?

1. Ten vocalists will be selected from the closed auditions to compete in the final performance on Sunday, August 27.
2. The judges of the closed auditions will be looking for performers that are entertaining, promising, have natural ability, quality of performance, showmanship and audience appeal.
3. All performances must be NO LONGER than FOUR MINUTES, 30 SECONDS in length.
4. Vocalists may perform with one instrument or a pre-recorded backup soundtrack CD without lead vocals included. SoCo LoCo and the South Snohomish County Chamber of Commerce will provide the sound system.
5. All lyrics must be suitable for a family audience and applicants agree to conduct themselves in a manner that will honor themselves during all stages of the competition.
6. At SoCo LoCo winners will be chosen by a three-judge panel. The performer receiving the greatest total score from the judges will be declared the winner. All decisions are final.
7. Each contestant gives permission to use their name and/or likeness for advertising, publicity and/or trade purposes without further compensation.
8. Parents must sign the application and other contractual material for any child under 18 years of age.
9. Entry is limited to the first 60 applicants and a non-refundable \$10 entry fee must accompany each application. Applications will be accepted on a first-come, first-served basis. As such, pre-registration is strongly advised.
